

Notice of Variation to your Terms and Conditions

1 May 2021



This variation notice applies to:

- the Suncorp Credit Card Rewards and Suncorp Credit Card Qantas Frequent Flyer Rewards for Suncorp Clear Options Personal Credit Cards Terms and Conditions; and
- the Suncorp Credit Card Terms and Conditions and Other Important Information

 - b. a new section or sub-section is shown as "new";
 - c. a deleted section or sub-section is shown as "deleted".

Section 4. Adjustments and Deductions to your Rewards Balance

We've clarified the way we apply deductions to your Rewards Balance when you have any refunds or reimbursements for Eligible Transactions that you earned Points on.

4.2 When you obtain a refund or reimbursement in respect of an Eligible Transaction pursuant to which you earned Points (for example, as a result of returned goods or services or a disputed transaction), your Rewards Balance will be reduced accordingly.	4.2 When you obtain a refund or reimbursement for an Eligible Transaction that you earned Points on (e.g. from returning goods or services or a disputed transaction) (Reversed Transaction) the total number of Points you earned for the Reversed Transaction will be deducted from the total number of Points you actually received and would have received (e.g. points not earned due to the maximum spend limits being reached) for Eligible Transactions during the Statement Period in which the Reversed Transaction was posted.

Section 2. Use of Cards and the Account

Limits on use

We have included reference to crypto currency related transactions as transactions you cannot make on your credit card. Accordingly, we've updated the final bullet of the clause as follows:

What should you do if you have a complaint?

We have reduced the timeframe in which we will aim to resolve new complaints from 45 days to 30 days. To reflect this, we have amended the last paragraph in this clause.

<p>Once you have contacted the Credit Provider, we will begin the process of investigating and resolving your complaint. We will try to resolve your complaint quickly and fairly. We will endeavour to resolve your complaint within 3 business days, however some complaints do take more time than others. If we anticipate that your complaint will take longer than 21 days to resolve, we will contact you within this time to provide you with an update on our progress. Should it take longer than 45 days, we will contact you in writing to provide an explanation of the reason for the delay.</p>	<p>Once you have contacted the Credit Provider, we will begin the process of investigating and resolving your complaint. We will try to resolve your complaint quickly and fairly, however some complaints do take more time than others. If we anticipate that your complaint will take longer than 21 days to resolve, we will contact you within this time to provide you with an update on our progress. If we are unable to resolve your complaint within 30 days (or within 21 days if it involves a hardship notice, default notice or request to postpone enforcement), we will:</p> <ol style="list-style-type: none"> tell you the reasons for the delay; tell you the date by which you can reasonably expect to hear the outcome of our investigation; and

	<p>c) give you monthly updates on the progress;</p> <p>d) tell you about your right to complain to the Australian Financial Complaints Authority (AFCA) if you are dissatisfied; and</p> <p>e) provide you with contact details for AFCA (also set out below).</p> <p>For complaints involving hardship notice, default notice or request to postpone enforcement, exceptions apply to the 21 day timeframe if we do not have sufficient information to make a decision or we reach an agreement with you. If we require further information from you, then we will request it within 21 days of receiving the complaint.</p>
